As a Proposed Member, this signed application must be reviewed and approved by the Board. A ten-day letter will be placed before the membership for two weeks. During that two-week period, you will not attend the regular Thursday Noon meeting. Upon approval, or rejection, you will be notified:

I understand that it will be my duty, if admitted, to exemplify the Object of Rotary in all my daily contacts and activities and to abide by the constitution of Rotary International and this club. I agree to pay a one-time initiation fee of **\$100*** plus the annual dues and fees as shown below in accordance with the bylaws of the club. I hereby give permission to the club to publish my name and proposed classification to its membership."

NEW MEMBER RESPONSIBILITIES:

Attend a new member orientation of the Rotary Club of Clayton prior to induction.

Strive for 100% attendance. Club committee meetings, events or functions, and any District or RI functions are permissible "make-ups." Make-ups should occur within 14 days either before or after missed club meeting.

Pay financial commitments in a timely manner.

Visit and meet members at each meeting.

Volunteer for club activities.

Participate in at least one club committee.

Present a vocational talk at a future club meeting.

Spend time learning about Rotary International.

Quarterly FEES: (All dues and charges are the sole responsibility of the member)

Georgia Rotary Student Supplemental Fees = \$ 6.00

Member Quarterly Meals = \$150 (\$12 weekly)

Rotary International Dues = \$ 19.25 (includes monthly subscription to *ROTARIAN*)

Clayton Rotary Foundation Contribution = \$25 (Optional)

Paul Harris Quarterly Contribution = \$ 25 (optional)

Georgia Rotary Student Endowment Program = \$ 25 (optional)

Total Suggested Quarterly Charges = \$ 312.25 (billed quarterly in Jan., Apr., July, Oct.)

ADDITIONAL FEES BILLED AS INDICATED:
